A meeting of the City Council of the City of Jamestown, New York was held on Monday, January 6, 2014 at 7:00 p.m.

Director of Financial Services/City Clerk James N. Olson called the 2014-2015 meeting of the Jamestown City Council to order and led the assembly in the Pledge of Allegiance to the flag.

The Rev. Angus Watkins of the Unitarian Universalist Congregation of Jamestown gave the invocation.

Mayor Teresi: Before I administer the oath to Judge LaMancuso, the oath that will be administered to him for the third time now as our City Court Judge. I listened to some of the terrific and inspiring remarks earlier tonight and I heard the word honor mentioned on many occasions. It is now my opportunity to join the honor train and state that this is a high honor for me to be able to - for the second time now - to be asked by Judge LaMancuso to administer this oath of office to him. I had the opportunity as Mayor back in 2004. January 1st, 2004 to administer the oath to the judge who then turned around and administered the oath to me, as Mayor of Jamestown on that same day. And, as high an honor, Judge, as it is that you asked me to administer this oath to you, it's been easily eclipsed by the fact that you have administered the oath to me the four times that I've had the opportunity to stand before the people of Jamestown. That's truly been one of the highest honors I've had in public service. This is a good man, and a great public servant, somebody that I've known for all my years, actually I first knew him and revered him when he was a key member of that 1971-72 Jamestown High School Red Raider basketball team. One of the best high school teams, not just in New York State, but in the country at the time. I then kind of watched him from afar, he was a classmate of my sister's at

Jamestown High School and actually came to know the man as a young aspiring public servant and attorney in the community and had the opportunity and the honor to work on your first campaign for City Court Judge and now the honor comes full circle, being able to administer this oath of office to you, Your Honor. Please place your hand on the Bible, raise your right hand and repeat after me.

Council President Rabb: I know I just spoke to you a few moments ago, but that was as the outgoing president. Now I get to speak to you as the new president. I want to once again thank

Bring forth the strong ideas and work together with each other in a partnership with the public and private sectors to bring about the future we all want. And so, I charge the Finance Committee to continue to look for ways to save on expenses and increase our revenues using all of our many assets to the benefit of Jamestown including our enterprise funds. I charge the Public Safety Committee to continue our progress as we study police consolidation in the face of substance abuse and domestic violence and the harm they cause to the people of our city. I charge Public Works Committee to continue to find innovative ways to replace our aging equipment and keep our streets, sidewalks, parks, and playgrounds, including our ever-expanding Riverwalk in the good condition we all want them to be. And I charge the Housing Committee to continue our work with the Jamestown Renaissance Corporation to strengthen our neighborhoods, enforce our building codes and expand housing opportunities for those among us who have physical limitations.
