A meeting of the City Council of the City of Jamestown, New York was held on Monday, March 31, 2014 at 7:30 p.m.

City Clerk James N. Olson called the meeting to order in the absence of Council President Rabb and led the assembly in the Pledge of Allegiance to the Flag.

MESSAGES FROM THE MAYOR/COUNCIL PRESIDENT

Mayor Teresi: Thank you Mr. President and members of City Council. On behalf of City Council President Greg Rabb, who is out of the country and cannot be here tonight, I'd like to welcome everyone to the Jamestown Municipal Building and tonight's regular meeting of the Jamestown City Council which is anything but regular tonight because of the very special guests that join us at tonight's meeting. It is our pleasure to honor the members of the Jamestown High School young men's basketball team for a whole variety of your encore accomplishments through this past season. Let me just take a moment to recount a couple of those for you. A 19-5

record, including winning 16 out of their last 18 games, yet another ECIC Division 1 Championship, another Section 6 Championship – Buffalo State Sports Arena is starting to become our home away from home and that's a wonderful thing – congratulations guys. Far West Regional Championship, beating a very talented Greece Athena team, who earlier this season, when we were a very, very different team at the beginning of the year, defeated our team. Second ever Final Four appearance Large School Division by Jamestown High School basketball team. That round one heart-stopping loss to Union Endicott High School. Could you guys have made it any more dramatic and closer? But, I want to thank you on a personal note, here because I have bragging rights in the Teresi family because my cousins went to Union Endicott High School, so thank you for giving me bragging rights, and that outstanding nail biter performance in the final game. That was amazing. What you accomplished this season was absolutely amazing. And in my book as I was telling the young men here earlier tonight, when they first arrived at City Council Chambers – in my book, this team did the elite basketball royalty classification of some very, very, very, outstanding teams down through the years to play at Jamestown High School. 1966 team with Don Johnston, went on to play for Dean Smith at North Carolina, 1971-72 team headed by Terry Chile who played at Duke, Mark Edstrom, Steve Waite, and a whole variety of other players including our own Judge LaMancuso here in Jamestown. Those were the days before they had playoffs outside of our own regional championship. That team, gentlemen, probably not only the best team in New York State, it was probably one of the best high school teams in the country. To play a game at Jamestown High School that year against the Number 1 rated high school basketball team in the nation, the Pittsburgh Scheuley High School, with 2 future NBA players on there, Maurice Lucas and Gene Kelly and we beat them at Jamestown High School and you gentlemen are right up there with teams like that. Maceo led the team in the 1990s, great team in 1979 and 80 with Mike McElrath, Tyrone Beaman, Jimmy Giunta, Sam Restivo, and a whole bunch of great players, and also your predecessor in the Final Four in 2011, team headed by Jayshawn Page, Aaron Huntz, Adam Cechini, Joey Campion, Tom Campion, and also the team last year with a couple of bounces of the ball would have gone to Glens Falls. What you guys accomplished this year was absolutely amazing. Particularly when you stop to realize – and I want my Council friends to know this – you weren't supposed to be there, didn't you know that? All the basketball elite told you, you're too young, you're too inexperienced, you lost too many guys from last year, you're too small, you're not physical enough. But obviously, either they failed to tell you that, or you got the memo and didn't read it. Because you proved them all wrong and you went out there and you showed them what Jamestown ball players are about and what this city is about. I was telling Scott Kindberg at Glens Falls that day, before the game, that your basketball team is like a metaphor for this community. All we have is a lot of guts and determination in the community every time we get knocked down, we pull ourselves back up and we prove the rest of the world wrong. That's what your team did. A wise man once told me, it's not just about what you do, but about how you do it that really tells what you're made of and when you told the world what you're made of because you're a gutsy group of classy guys that play as a team and that was impressive and that was inspiring. Tonight isn't just a celebration of what you accomplished and the notoriety that put us on the map once again. Tonight's a celebration of the youth of our community in general. The youth of our community that are not only out there winning basketball championships, inspiring young people around the community, the youth of the community, the youth of the Jamestown Public School district that are out there doing great things every day. On stage, on the football field, from a dance hall, to the classroom, you are

doing that because we have a wonderful school district here. Truly one of the greatest assets this community ever could ask for and it's my pleasure to ask to join me up here, my colleague in public service and government on the other side of government ledger – the public school side, our Superintendent Tim Mains. Tim, would you like to come up and say a few words...Now, you've probably heard of a guy that rips open his chest, and he has an S on it and he's called Superman, they've kind of morphed together Superintendent Mains is the one that when I introduced you to Supermains.

Mr. Mains: Mr. Mayor, I greatly appreciate your personal support for our district and for our team. It did my heart good to know that you were there in Glens Falls, we were there cheering on our team, it's valuable to me to know that this community celebrates and embraces the talent that we have in the district and particularly at the High School. I know that our team wanted to win that final game and I told several of them individually and I told their coach repeatedly that they are winners that they are more than winners. They competed in a championship and champions are more than winners. Champions don't just vanquish their foes champions don't just win either. Champions are respected for their skill and their character. I had the benefit of watching these young men grow through the course of the season. I've watched a lot of them play football. I'm finally learning their names and recognizing and telling the difference between one and the other now that they don't have helmets and pads on. But, I was amazed to watch them grow in skill. To watch them grow in their facility to work as a team throughout this season. I attended that basketball game against Greece Athena High School, where I once worked and was disappointed that Athena won. I was delighted when I watched this team vanquish Athena on the court in Buffalo and I felt vindicated. But, not because they won, not just winners, I will repeat champions. I will tell you that in my eyes every single gentleman on this team and every member of the coaching staff are champions. They have represented us well. They are respected throughout the region and throughout the state. So I am particularly pleased that the City has chosen to recognize the skill and the character of these young champions tonight, because I believe they've accomplished a lot this year. And I believe they will continue to carry that into the work that they do both in their remainder of time with us at JHS and beyond. Thank you.

Mayor Teresi: We've mentioned the word team probably twenty times tonight and that was the difference between you and some other programs that I watched you play this year and recently. You're a team because you have outstanding leadership, on court leadership, but you have community leadership, and probably the best coaching staff that you will find anywhere in New York State. At best you've got great administration. And, most importantly you have a community and you have family behind you, and you have a booster club behind you, and I want to recognize the parents and the booster club members. If you would please stand up and be recognized.

Mayor Teresi: Now, I'd like to introduce and have join us up here, Principal Dr. Mike McElrath. Mike would you come up? More importantly, he was amazing back in 1979 and 1980. One of the best I've ever seen.

Mayor Teresi: Second of all, you have an outstanding coaching staff here and I see two of the assistants out there, Tage Hall and Bill Miley can you join us up here, please?

Mayor Teresi: I remember this guy when he was the ball boy for Nick Creola's Jayhawk basketball team back in the 1980s. He was out there doing the pre-game drills for some of the most talented junior college players in the country, then went on to an outstanding career at Jamestown High School and a collegiate career as well, and today pound for pound, inch for inch, grain of salt for grain of salt, I'll pick Ben Drake over any coach in the country to coach our students.

Mayor Teresi: And, last but not least, I'd like to invite up one by one, the members of this championship team here today and I'm going to ask you not to reserve your applause for them. Let's give these kids the credit that's due to them.

WHEREAS, the scope of JURA activity has grown to include residential housing code enforcement and rehabilitation, commercial building code enforcement, neighborhood preservation and improvement, zoning activities, community planning, grant administration, and economic development; and

WHEREAS, the City of Jamestown maintains the desire and responsibility to protect the safety and improve the quality of life for all of its residents through the proper enforcement of life and safety codes, the upgrading of the environment within its neighborhoods, rebuilding infrastructure, and stimulating the retention and creation of jobs in the industrial, service and commercial sectors; and

WHEREAS, JURA has demonstrated since its inception that it is adequately equipped and fully capable to develop, obtain funding for, and implement a variety of programs and activities to address the city's public safety and community/economic development objectives; and

WHEREAS, the City has determined that it is efficient, cost effective, and desirable to contract with JURA for delivery of these essential services and activities; now therefore be it

RESOLVED, that the Mayor be and is hereby authorized to enter into an agreement with the Jamestown Urban Renewal Agency for the 2014 fiscal year to provide the following city services and pursue the following activities:

- Enforcement of Chapter 215 of the Jamestown City Code – the Property Rehabilitation and Conservation Code.
- Enforcement of the New York State Uniform Fire Prevention and Building Code.

- Enforcement of Chapter 300 of the Jamestown City Code – the Zoning Code for the City of Jamestown.
- Operation of the city’s various housing rehabilitation and neighborhood improvement initiatives.
- Application for an administration of housing and economic development grant programs including, but not limited to; HUD’s CDBG and HOME Program entitlements; the NYS Brownfield Opportunity Area Program Grant; NYS Main Street Grant; NYS Quality Communities Grant; and RESTORE NY Grant.
- Administration of the Federal Renewal Community Tax Incentive Program.
- Administration of all long and short-term planning activities.
- Marketing of the community and response to development-related inquiries.
- Packaging of sites for city-sponsored projects.

RESOLVED, that in consideration of said services and activities, the City will allocate to JURA during FY 2014 a lump sum that shall not be less than \$364,000 and provide an in-kind contribution of office space, utilities, and parking for JURA vehicles at the Jamestown Municipal Building, and authorize JURA to retain all administrative revenues from housing and community/economic development grants obtained and administered by JURA on behalf of the city.
